Ray Sparks announced that Judy Johnson has

resigned her positions with the club. She was presented with a rose for her garden and several members presented her with a gift.

The board has decided to divide Judys role into 3 parts due to recommendations from our CPA and ease the burder of those in the role. We will continue to have a Secretary and Treasurer, roles that should no longer be filled by the same person. In addition we will hire an outside Bookkeeper. Payments will continue to go to our same P.O. Box.

The two CPA Recommendations are as follows.

The duties of Secretary and that of an acting Treasurer are currently combined functions that should be separated. The person with check-signing authority should not be the same person that approves expense reimbursements or that record in the minutes where all expense reports were approved.

In addition, your By-laws state in Article V, Section 2 that, "the Board of Directors shall not be paid a salary." However, the acting Treasurer and Secretary is being paid a salary for her bookkeeping duties. While it is reasonable that she should be paid for this service, the Board should decide whether to amend the by-laws to include a provision for salary for the bookkeeper (acting as Treasurer), or the bookkeeper should not be a member of the board. #2533 William Quick made a motion to accept the January-February 2017 General Meeting Minutes. #3352 Ann seconded. Motion carried and passed.

#### **New Properties Finders Fee**

It is the policy of the WEGM to reward its members with a finders fee for locating new properties for the club to lease. The member will be paid \$240 or receive credit for \$240 in membership dues upon the club approving the lease for club use. The member must act as an agent between the landowner and the WEGM. To receive the finders fee, you must register in writing with the club secretary your intent to begin discussing a proposed lease with the landowner. You cannot receive the finders fee unless registration is complete and the lease is approved by the WEGM.
