New Properties Finders Fee

It is the policy of the WEGM to reward its members with a finders fee for locating new properties for the club to lease. The member will be paid \$240 or receive credit for \$240 in membership dues upon the club approving the lease for club use. The member must act as an agent between the landowner and the WEGM. To receive the finders fee, you must register in writing with the club secretary your intent to begin discussing a proposed lease with the landowner. You cannot receive the finders fee unless registration is complete and the lease is approved by the WEGM.

MOORE FROM THE GOLD FIELDS:

A word about mining safety. This time of the year we have a lot of storms through the area. The river will rise very rapidly after a rain, even upstream. It may be sunny at your spot. You may be under water dredging and suddenly find yourself being washed down stream or large boulders are moving and falling into your dredge hole. If you hear scraping sounds while dredging, this is boulders being washed down stream. This has happened to me a few times. If you have trouble staying on the bottom or the water starts clouding, you should surface and check the weather conditions. In the past I have seen good conditions change to dangerous conditions in just a few minutes time. When you get out tie your dredge as highs you can. I have seen the water rise several feet in a short time, pulling dredges underwater and flooding the camps next to the river. Sometimes if tied too low the stress causes the dredge to break loose. Even if pulled out the dredge should be tied to a sturdy branch above your head. This happen on our properties. Even beware of camps too close to the river. Be safe and have fun.


